**Treasurer**: Deposits funds for the chapter and maintains financial accounts. Maintains financial records. Makes monthly financial reports. Signs checks for approved spending and arranges for cosigners. Submits books and records for annual audits to trustees. Currently the treasurer has transported and managed the PA system, but these duties are not tied to the office. Currently: Dennis Montgomery

**Executive Board Members** (four): Represent the interests of the membership at executive board meetings. Currently: Mark Adams, Arneta Henninger, Katie Kerfonta, Annette McCully

**Trustees** (three): Review books annually with the Treasurer. Currently: Barbara Gelsleichter, Charles Gelsleichter, Jan Hemingway

**Convention Delegates:** Represent Chapter 46 at RPEC's Biennial Convention.


We are sending a short survey to members who have given us their email addresses to further refine our decision and will report the results at our March meeting.
